## 9th - 12th Tuition/Payment Agreement Form

Student's Name - Please enter one student's name per form.

By typing my name below, I agree to pay Cascade View Christian School a total of \$3,200, which may be paid in 10 monthly payments of \$320.00 per month. Payments are due by the 1st and past due by the 5th of each month. A late charge of \$20 will be added if payment is not received by the 10th of each month. If your check is returned for any reason, there is a \$35 bank charge.

*(Unfortunately, we are only able to accommodate one return check, after that we ask that you pay future tuition payment in cash or money order.)*

I understand that monthly payments are paid whether my child misses due to illness, vacation, holidays, snow days, or any other absence. I agree that if my payment is past due by two months that my child will not be able to continue in the Cascade View Christian School.

I agree to give a 30 day notice if I choose to remove my child from the program.

I agree to pay a \$100.00 non-refundable registration fee (This fee will ensure a place in our program for your child and pay for your child's supplies for preschool). There is also a \$320.00 curriculum fee. Our program has a limited number of places.

*The first completed enrollment forms AND paid registration fee to be turned in will be given a place.*

PLEASE NOTE THAT THE FIRST TUITION PAYMENT OF \$320.00 IS DUE AUGUST 5TH OR THE FIRST DAY OF SCHOOL AND WILL CONTINUE FOR 10 MONTHS ENDING WITH YOUR TENTH PAYMENT.

## **Enrollment Fee Agreement Form**

By submitting this enrollment paperwork for the 2020-2021 school year, I acknowledge that I am agreeing to pay the registration, curriculum, and tuition fee listed above. If I owe more than \$1,000.00 at the end of the school year, I understand that my student will not be able to return to CVCS the following fall unless my balance is paid in full before July 31, 2020.

I understand that if I get behind in my payments, I should notify the CVCS director and treasurer to let them know what is going on. I will do my best to make small payments (\$25 and up) towards the fees I owe each month.
